BOROUGH AUDITOR: Motion made by Travis Enders, seconded by Russell Snyder to reappoint Patton and Lettich as Borough Auditor. Motion carried.

CHIEF ADMINISTRATIVE OFFICER: Motion made by Mandy Carl, seconded by Russell Snyder to reappoint Peggy Kahler, Borough Secretary; as the Chief Administrative Officer for the Elizabethville Borough Non-Union Pension Plan. Motion carried.

EMERGENCY MANAGEMENT COORDINATOR: Motion made by Mandy Carl, seconded by Travis Enders to appoint Russell Walborn Sr. as the Emergency Management Coordinator for the Borough of Elizabethville. Motion carried.
